AUDIT FINDINGS

Narrative:

The audit of the Rolette County Jail (RCJ) was conducted on June 7 and June 8, 2018. Candy Snyder, a certified auditor, and Mark Snyder, auditor assistant, conducted the audit. The audit team conducted a review of the files, a facility tour and on-site interviews.

The audit began with an entrance briefing on Thursday, June 7, 2018 attended by the Jail Administrator, Kimberly Nadeau and her assistant/correctional officer, Amber Davis. The team then briefed and interviewed Sheriff Gerald Medrud. Following the meeting with the sheriff the audit team toured the facility. The audit team ended the first day with interviews of specialized and random staff and continued into the evening hours with the second shift. On the second day of the audit the audit team interviewed inmates and finalized the staff interviews. The audit concluded with an exit briefing attended by the Jail Administrator.

The tour began with the administrative spaces and then continued into the jail. Every area of the jail was viewed by the audit team. The tour was conducted by both females and males and staff announced appropriately as visitors were entering the housing units. The auditor noted the privacy provided by showers from cross-gender viewing; the location of toilets within the cells in relation to surveillance camera placement; potential blind spots; posting of the PREA information poster and the audit notice.

We began the tour from the inmate's perspective with first the vehicle sally port and the booking area. Offenders are screened, classified, searched and provided clothing. Initial information is given regarding PREA and how to report any allegations of sexual harassment or sexual abuse. There are cameras in the booking area. The screening instrument is pre-loaded into the computerized booking software. The booking officer cannot continue with the process until all questions have been asked and entered into the system.

The facility contracts with a Registered Nurse (RN) to provide sick call services and conduct the initial screening. She is on site twice each week and as needed for call-in services. The RN determines if further care is necessary and if so the inmate is transported to Presentation Medical Center or Indian Health Services in Belcourt. The medical area is private and can provide for the medical care and emotional support as well as a private area for the victim to be interviewed prior to transportation to the hospital for a forensic examination. There are no other contractors or volunteers currently employed at the jail. The food is catered by a local establishment and the inmates are served by the correctional officers in their dayroom.

The audit team examined the recreation area. The area has excellent camera coverage. The gym is a large area that is monitored by two cameras. All inmates are offered an hour of physical activity each day. The recreation area has one large louvered gate that opens to allow fresh air and natural light in.

There are four housing units at RCJ. All units had posters designating how to report sexual assault or sexual harassment, and a kiosk available to report via an electronic message to the jail administrator. All units had adequate camera coverage and an intercom that allows inmates to speak directly to Master Control if immediate assistance is needed. Jail staff check every housing unit on rounds at a minimum of once each hour. The audit team directly witnessed rounds being conducted consistently.

Typically, the suspected perpetrator of a sexual assault would be removed to a confinement area. In some instances a victim may be placed in an alternate housing unit for their protection, but not segregation or isolation. However, a victim of a sexual assault could be placed in segregation if he/she requested it for protective custody.

During the tour work areas were inspected to include the kitchen and the laundry. There are multiple cameras within both of these work areas.

The Master Control is operated continuously by a staff member who operates the door control touch screen controls, the camera monitors and the intercom system. There is very comprehensive camera coverage in all the housing units, hallways and shared use areas. The auditor checked each camera to ensure that no camera could view toilet or shower areas. For the electrical and custodial closets and storage rooms, there are no cameras within these rooms or windows in the doors, but there are cameras covering the entrances to these rooms.

At the time of the audit the jail had a population of ten inmates and all inmates were privately interviewed except one who declined as he was sleeping and did not want to get up. The jail does not house youthful offenders. The auditor reviewed intake screenings and conducted specialty interviews if indicated. There were no offenders with limited English speaking ability, no offenders with a reported sexual abuse incident and no offenders who disclosed prior sexual victimization. There were no offenders who identified as being transgender or intersex. There was one inmate interviewed who identified as gay, lesbian, or bisexual in the facility during the time of the audit. There were no offenders in segregated housing for risk of sexual victimization. The auditor used the Adult Prisons and Jails interview protocols for "Random Sample of Inmates" and the appropriate specialty interview guides where applicable. Before starting, the inmates were informed of the audit's purpose and the reason for their requested participation.

There are a total of 19 staff at the jail, five of which are part time. As this is a small facility, several staff work in multiple roles. For example, the Jail Administrator also is the PREA Coordinator, and leads the incident review team. All line staff are trained to perform screenings for risk of victimization and abuse at intake and conduct the intake process.

The auditor interviewed ten (10) correctional officers from both shifts. Interviews were conducted with employees identified as specialized staff or staff working in specialized areas. The specialized staff selected for interview included the Jail Administrator, the Investigator and the Director of Nursing, Staff who performed screenings, first responders, those who supervise segregated housing and conduct searches.

The RCJ has relatively recently undertook their PREA compliance efforts, but has a very good start. They jail administrator has sought guidance from a neighboring county's PREA Coordinator and has been developing some good internal controls aimed at complying with all PREA standards and housing inmates safely and free of sexual assault and sexual harassment. The auditor examined randomly

selected personnel files. The Jail Administrator completes all hiring and maintains personnel files. The auditor randomly selected employment files. The files were organized and contained all the necessary background check information. Training documentation is maintained within their file. The auditor verified through written documentation that the correctional officers received the required training.

On June 8, 2018 the auditor conducted the exit meeting. The auditor provided preliminary information for each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the report. It was apparent that the facility staff take their responsibility to keep the inmates safe with earnest and are committed to following all PREA Standards completely.

AUDIT FINDINGS

Facility Characteristics:

The Rolette County Jail (RCJ) is located in Rolla, North Dakota and is located in the newly constructed Rolette County Law Enforcement Center. The facility includes the county sheriff, the city police department, dispatch and the jail. The jail is a 48-bed facility. Inmates occupied the new jail in January 2018.

The RCJ houses minimum, medium, and maximum security inmates. The facility houses inmates from Rolette County and neighboring counties both sentenced and those awaiting court as well as federal inmates from the U.S. Marshalls and state inmates from the North Dakota Department of Corrections and Rehabilitation. The administrative spaces consist of the law enforcement center lobby, administrative offices, a training room, and an interview room. The jail is operated through the Master Control. This area is divided into two halves – one half is dedicated to law enforcement dispatch and the other half is for the Master Control of the jail. In Master Control the officer controls jail doors, monitors radio traffic, observes cameras, monitors and responds to the intercom system throughout the jail and views through security glass the housing areas that are located directly across from the Master Control.

Inmates enter through the vehicle sally port. They then proceed to the pre-book waiting area. There is a search/change area that has a shower and a toilet. This is where newly arrived offenders are searched and change out into jail clothing. There are two holding cells within the booking area and a dayroom. The booking cells can accommodate four inmates. Each holding cell is doubled bunked and has a toilet/sink. The booking area consists of a booking desk and the required equipment necessary to book offenders into the jail. There is a medical office and an interview room as well as a property storage room in the booking area.

HOUSING UNITS:

The inmate housing area is divided into four distinct housing areas that spoke out directly across from the Master Control. All housing units are similarly situated with an upper and lower tier. The lower tier comprises of the dayroom at the front of the housing unit and the lower tier cells and a private shower at the rear of the housing unit. Stairs in the dayroom access the upper tier cells. Each cell is double bunked and has a toilet/sink.

Unit A houses six (6) male inmates. There is one double bunk cell on the lower tier and two double bunk cells on the upper tier.

Unit B houses twelve (12) male inmates. There are three double bunk cells on the lower tier and three double bunk cells on the upper tier.

Unit C houses 16 (16) male inmates. There are four double bunk cells on the lower tier and four double bunk cells on the upper tier.

Unit D house ten (10) female inmates. There are two double bunk cells on the lower tier and a subdayroom so that inmates within the lower tier can be separated from inmates housed in the upper tier. There are three double bunk cells on the upper tier. In addition to housing areas the facility includes an indoor/outdoor recreation area, a kitchen, a laundry room, a receiving area, a general storage room, an electrical/maintenance area and a chemical storage closet.

The Jail Administrator/PREA Coordinator for the Rolette County Jail is new to PREA compliance, but has done an exceptional job in getting the program underway since the new jail opened in January 2018. She has implemented many new policies and procedures and they are becoming ingrained in the daily activities of both staff and inmates.

Standard 115.13 Supervision and monitoring

CORRECTIVE ACTION: In order to be compliant with this standard the auditor required documentation of unannounced rounds throughout the corrective action period. The RCJ added a code to their Jail Management System to document unannounced rounds. They provided the auditor a report of the unannounced rounds conducted throughout the corrective action period by the jail administrator and her assistant. These rounds were documented within their P1 LERMS System. These rounds included varying times and days of the week -- some rounds were conducted on weekends, during the evening hours and the overnight shift.

Standard 115.15 Limits to cross gender viewing and searches

CORRECTIVE ACTION: The auditor requested attestation forms or other documentation showing that staff received training on cross-gender searches. The RCJ provided the requested documentation for search training.

Standard 115.17 Hiring and promotion decisions

CORRECTIVE ACTION: The auditor required that RCJ provide the method in which they will ask the three required questions relating to sexual misconduct and that they understand they have a continuing duty to report any sexual misconduct. RCJ provided documented evidence through the form they implemented that was signed by new hires during the corrective action period.

Standard 115.21 Evidence protocol and forensic medical examinations

CORRECTIVE ACTION: The auditor required an MOU or documented evidence of attempts to enter into an MOU with an advocacy service to provide support to victims of sexual assault. On July 26, 2018 the RCJ provided a copy of the MOU entered into with Bottineau Family Crisis Center for advocacy services.

Standard 115.22 Policies to ensure referrals of allegations for investigations

CORRECTIVE ACTION: The auditor required the RCJ post the investigative policy on its website. The RCJ posted policy 8.02 Investigations: Criminal and Administrative, Referrals, Coordinated Response on their website at http://www.rolettecounty.com

Standard 115.31 Employee training

CORRECTIVE ACTION: The auditor required RCJ provide documented evidence of training for all staff that acknowledges understanding of the information received during training and a training outline. The RCJ provided training documentation and the training outline as requested.

Standard 115.32 Volunteer and contractor training

CORRECTIVE ACTION: The auditor required RCJ provide documented evidence of basic PREA training provided to the medical provider to include both the training outline or materials and a signed acknowledgment of understanding of the training received. The RCJ provided the requested documentation to include both basic PREA training and specialized training for medical providers. The nurse completed the NIC's PREA: Medical Health Care for Sexual Assault Victims in a Confinement Setting.

Standard 115.33 Inmate education

CORRECTIVE ACTION: The auditor required the RCJ provide the more comprehensive information to inmates either through a video or in person. The training is to include their rights to be free from sexual abuse and sexual harassment; their rights to be free from retaliation for reporting and the agency policy and procedures for responding. The auditor required documented evidence that this training has been complete. The RCJ implemented new procedure in which inmates watch the PREA video every 3rd Wednesday of the month. A list is printed off of every inmate booked in within the past 30 days and inmates sign after viewing the video. Signature sheets are maintained on record and were provided to the auditor.

Standard 115.41 Screening for risk of victimization and abusiveness

CORRECTIVE ACTION: The auditor required that the RCJ devise a method for reevaluating an inmate's risk and documenting that reevaluation within 30 days of arrival. The RCJ implemented a new procedure in conjunction with Inmate Education. Inmates will be reevaluated the same day that the video is being viewed, every 3rd Wednesday. The RCJ provided their new reevaluation form to the auditor.

Standard 115.51 Inmate reporting

CORRECTIVE ACTION: The auditor required the RCJ enter into a MOU with an external entity that is willing to accept calls from inmates to report sexual abuse. The RCJ lists the North Dakota Department of Corrections and Rehabilitation or the North Dakota Bureau of Investigation as an external entity for inmates to report. However, they only provide address information for contact and there had been no ground work laid to ensure that these entitles are willing to accept the responsibility for reporting immediately back to the RCJ. During the corrective action period they entered into a MOU with the Bottineau Family Crisis Center and provided the signed copy of this MOU to the auditor. The auditor verified with the Family Crisis Center that they are willing to accept these calls and report back to the facility.

Standard 115.53 Inmate access to outside confidential support services.

CORRECTIVE ACTION: The auditor required the RCJ enter into a MOU to provide support services. The RCJ entered into an agreement with the Bottineau Family Crisis Center to provide these support services and provided the auditor with a signed copy of the MOU. The auditor spoke with the Family Crisis Center

who stated they have agreed to provide the services.

Standard 115.54 Third-party reporting

CORRECTIVE ACTION: The auditor required the RCJ provide information on how an individual can make a third party report on behalf of an inmate. The RCJ created a tri-fold pamphlet and posted this in visitation and in the waiting area. The pamphlet is given to inmates at booking and it is posted on their website. The brochure identifies information on how to report sexual abuse on behalf of an inmate.

Standard 115.73 Reporting to inmates

CORRECTIVE ACTION: The auditor required a documented method of reporting back to inmates. The facility provided the method and form used for documenting the report made to inmates following a sexual abuse investigation.

Standard 115.86 Sexual abuse incident reviews

CORRECTIVE ACTION: The auditor required the RCJ provide any incident reviews conducted through the corrective action period. The auditor recommended they have a form to guide them through the review process. These items were provided to the auditor as requested.

Standard 115.87 Data collection

CORRECTIVE ACTION: The auditor required the RCJ collect aggregate data and provide it to the auditor. The RCJ provided their 2017 Annual Report to the auditor, which contained the aggregate data.

Standard 115.88 Data review for corrective action

CORRECTIVE ACTION: The auditor required the RCJ prepare an annual review, prepare a report and provide it to the auditor as well as posting it to the county website. The RCJ posted their 2017 Annual Report on their website http://www.rolettecounty.com.

Standard 115.89 Data storage, publication and destruction

CORRECTIVE ACTION: The auditor required RCJ post aggregate data on the agency website. The RCJ posted their 2017 Annual Report which contained aggregate data on their website http://www.rolettecounty.com

	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ written policy 8.01 mandates zero tolerance toward all forms of sexual abuse and sexual harassment. During the interview, the Jail Administrator/PREA Coordinator stated that she has enough time to manage all of her PREA-related responsibilities. The staff indicated that she has met with them in person to communicate any PREA related issues or to give training or guidance on PREA policy or procedures. The Jail Administrator/PREA Coordinator has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards. She has implemented many policies and procedures since the jail opened in 2018 and has done a great job in ensuring that these new practices become a part of the overall culture and routine within the jail.

115.12	Contracting with other entities for the confinement of inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility does not contract for the confinement of its inmates with other private agencies/entities. They have an emergency plan to utilize the Heart of America Correctional and Treatment Center in the event of an emergency or natural disaster, but not as a facility to house inmates through a contractual relationship.

115.13	Supervision and monitoring
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ has developed, documented, and made its best efforts to comply on a regular basis with a staffing plan that provides for adequate levels of staffing. The Jail Administrator also explained that she checks for compliance with the staffing plan by inspecting the daily schedules. The facility is small and typically if there is a staff call-in, she is made aware of it. The auditor reviewed policy, the staffing plan, organizational structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. They use video monitoring, electronic door monitoring and an intercom system to protect inmates against sexual abuse. Higher-level supervisors conduct unannounced visits. However, these rounds were not documented.
	CORRECTIVE ACTION: In order to be compliant with this standard the auditor required documentation of unannounced rounds throughout the corrective action period. The RCJ added a code to their Jail Management System to document unannounced rounds. They provided the auditor a report of the unannounced rounds conducted throughout the corrective action period by the jail administrator and her assistant. These rounds were documented within their P1 LERMS System. These rounds included varying times and days of the week some rounds were conducted on weekends, during the evening hours and the overnight shift.

	Auditor Discussion
	The facility does not house youthful offenders.

115.15 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

RCJ does not conduct cross-gender strip searches or cross-gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners. The RCJ trains line staff in the proper methods to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The auditor verified this in interviews with staff. However, there was no documentation in the review of the training files. In the event a cross gender search is needed, RCJ will document all cross-gender strip searches and cross- gender visual body cavity searches. There have been no cross-gender searches for this audit review period. All interviews with both inmates and staff confirmed the practice of male staff searching male inmates and female staff searching female inmates. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates.

RCJ has policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures require staff of the opposite gender to announce their presence when entering an inmate housing unit. The auditor directly witnessed announcements throughout the audit and the practice was confirmed through both staff and inmate interviews. All camera views were adequately blocked to ensure that inmates have privacy to toilet, shower and change their clothing.

RCJ will not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. If the inmate's genital status is unknown, it is determined during conversations with the inmate, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner.

CORRECTIVE ACTION: The auditor requested attestation forms or other documentation showing that staff received training on cross-gender searches. The RCJ provided the requested documentation for search training.

115.16	Inmates with disabilities and inmates who are limited English proficient
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	RCJ provides interpretive services for inmates with disabilities or who are limited English proficient through a commercial service, the LanguageLine. The county emergency manager has set up the account and provided laminated materials to all jail staff. The inmates can point to their native language on a poster so that staff know which language is required. One of these notices is posted at the booking desk to assist the officer in contacting the LanguageLine interpretive services during the booking process. The RCJ does not rely on inmate interpreters or inmate readers and staff are aware of this policy as was verified during interviews with the staff.

115.17 Hiring and promotion decisions Auditor Overall Determination: Meets Standard **Auditor Discussion** RCJ conducts criminal background checks on applicants before an offer of employment is made. The auditor reviewed a random sampling of employee files and found some background checks were last ran in 2013 and were right at the five year point. The RCJ staff re-ran all employees background checks that were at the five year point and provided them to the auditor prior to the end of the first day of the on-site portion of the audit. The necessary background checks were ran prior to employment/service. The RCJ did not ask the three required questions outlined in this standard of perspective employees, volunteers or contractors or when considering staff for promotion. These questions are have you ever: 1) engaged in sexual abuse in any criminal justice facility: 2) been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or 3) been civilly or administratively adjudicated to have engaged in the activity described above. In addition, they did not have a method of documenting that staff understand they have a continuing duty to report any such misconduct. CORRECTIVE ACTION: The auditor required that RCJ provide the method in which they will ask the three required questions relating to sexual misconduct and that they understand they have a continuing duty to report any sexual misconduct. RCJ provided documented evidence through the form they implemented that was signed by new hires during the corrective action period.

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	RCJ moved into a new facility in January 2018. The new facility has the latest in technology to include video monitoring systems, door access systems, and an intercom system. The facility has clear sight lines from the Master Control into the housing units for direct observation. In interviewing both the Sheriff and the Jail Administrator they consider how such technology may enhance their ability to protect inmates from sexual abuse.

115.21	Evidence protocol and forensic medical examinations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	RCJ has a trained facility investigator to conduct administrative investigations. The investigator has completed the PREA investigator training provided by North Dakota Department of Corrections and Rehabilitation. All criminal allegations are turned over to the North Dakota Bureau of Investigation to conduct the investigation.
	Victims of sexual abuse have access to forensic medical exams by a SANE nurse through Indian Health Services (IHS) on the Turtle Mountain Reservation. If the victim is not eligible for medical services at IHS, the forensic medical exam can be completed by an emergency room doctor at the Presentation Medical Center. The next closest SANE nurses are located in Rugby or Trinity Health in Minot. There is only one SANE nurse for forensic exams at the hospital in Rugby and she may not always be available. However, in Minot at Trinity Hospital SANE nurses are available at any time. The facility did not have an MOU with a rape crisis center for advocacy services at the time of the on-site portion of the audit.
	CORRECTIVE ACTION: The auditor required an MOU or documented evidence of attempts to enter into an MOU with an advocacy service to provide support to victims of sexual assault. On July 26, 2018 the RCJ provided a copy of the MOU entered into with Bottineau Family

	Investigative steps are properly outlined in the PREA policy number 8.08 Investigations. Interviews with the investigator, Sheriff and the Jail Administrator/PREA Coordinator confirmed that the RCJ ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment. RCJ ensures that allegations of employee wrongdoing are referred for investigation to the North Dakota Division of Criminal Investigation. At the time of the on-site portion of the audit the investigative policy was not posted on the facility's website as required.
	CORRECTIVE ACTION: The auditor required the RCJ post the investigative policy on its website. The RCJ posted policy 8.02 Investigations: Criminal and Administrative, Referrals, Coordinated Response on their website at http://www.rolettecounty.com

Staff were knowledgeable in how to recognize signs of sexual abuse and how to communicate effectively with LGBTI inmates. Although training was presented to all staff, there is not a training outline describing the specific sections of the training presented. There was no training documentation requiring that staff acknowledge understanding the training they have received and sign.
	CORRECTIVE ACTION: The auditor required RCJ provide documented evidence of training for all staff that acknowledges understanding of the information received during training and a training outline. The RCJ provided training documentation and the training outline as requested.

	The facility only has one contractor, the medical provider. She stated she knew the basics — that there was a zero tolerance policy and to report any reports of sexual assault or harassment to the Jail Administrator. There was no documented training for this contractor.
	CORRECTIVE ACTION: The auditor required RCJ provide documented evidence of basic PREA training provided to the medical provider to include both the training outline or materials and a signed acknowledgment of understanding of the training received. The RCJ provided the requested documentation to include both basic PREA training and specialized training for medical providers. The nurse completed the NIC's PREA: Medical Health Care for Sexual Assault Victims in a Confinement Setting.

Inmate education Auditor Overall Determination: Meets Standard Auditor Discussion The inmates receive basic information during booking and are given a handbook on the day of arrival that outlines important PREA information. This basic information included the agency's zero tolerance policy and how to report an incident of sexual abuse or sexual harassment. The auditor requested an inmate show her the PREA information available to him on the kiosk within their housing unit. When an inmate initially signs on to the kiosk for the first time the

The auditor requested an inmate show her the PREA information available to him on the kiosk within their housing unit. When an inmate initially signs on to the kiosk for the first time the screen displays PREA information. The kiosk has the phone number to call the Family Crisis Center in Bottineau, the National Rape Crisis Center hotline number and addresses to write to the Department of Corrections and the North Dakota Bureau of Investigation. The kiosk information describes the grievance process in relation to sexual assault and describes the importance of seeking medical help and maintaining evidence by not showering. The inmate must acknowledge having read this information before having access to the kiosk. The information is then available to them throughout their stay. However, the standard requires that the more comprehensive information be provided either in person or through a video. In addition, it must include their rights to be free from sexual abuse and sexual harassment; their rights to be free from retaliation for reporting and the agency policy and procedures for responding.

CORRECTIVE ACTION: The auditor required the RCJ provide the more comprehensive information to inmates either through a video or in person. The training is to include their rights to be free from sexual abuse and sexual harassment; their rights to be free from retaliation for reporting and the agency policy and procedures for responding. The auditor required documented evidence that this training has been complete. The RCJ implemented new procedure in which inmates watch the PREA video every 3rd Wednesday of the month. A list is printed off of every inmate booked in within the past 30 days and inmates sign after viewing the video. Signature sheets are maintained on record and were provided to the auditor.

115.34	Specialized training: Investigations

	RCJ has trained a facility investigator to conduct administrative investigations. The PREA investigator completed specialized training provided by North Dakota Department of Corrections and Rehabilitation All criminal allegations are turned over to the North Dakota Bureau of Investigation.

	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Registered Nurse is contracted for services. During the interview the RN was very knowledgeable about the appropriate response for transporting the inmate to the hospital for sexual assault forensic exams and protecting evidence to aid in the prosecution of a sexual assault. The RCJ does not provide in-house mental health services. Inmates are referred to a provider at the Lake Region Human Services Center or Indian Health Services Behavioral Health in Belcourt for mental health care.

115.41	Screening for risk of victimization and abusiveness

	Auditor Discussion
	All inmates are assessed during an intake screening for risk of being sexually abused by other inmates or sexually abusive toward other inmates. Intake screenings usually take place within the first few hours but most definitely within 72 hours of arrival at the RCJ. The RCJ uses an objective screening instrument. However, the inmates were not reassessed within 30 days of arrival. The Jail Administrator does reevaluate when there is an incident, upon request or when there is additional information. However, reassessments are not documented.
	CORRECTIVE ACTION: The auditor required that the RCJ devise a method for reevaluating an inmate's risk and documenting that reevaluation within 30 days of arrival. The RCJ implemented a new procedure in conjunction with Inmate Education. Inmates will be reevaluated the same day that the video is being viewed, every 3rd Wednesday. The RCJ provided their new reevaluation form to the auditor.

	RCJ makes individualized determinations about how to ensure the safety of each inmate. In deciding whether to assign a transgender or intersex inmate to a housing unit for male or female inmates, and in making other housing and programming assignments, RCJ considers on a case-by-case basis whether a placement would ensure the inmate's health and safety, and whether the placement would present management or security problems. A transgender or intersex inmate's own views with respect to his or her own safety would be given serious consideration. All inmates shower separately. RCJ does not place lesbian, gay, bisexual, transgender, or intersex inmates in dedicated units solely on the basis of such identification. An inmate's risk level is reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information that bears on the inmate's risk of sexual victimization or abusiveness. Inmates are not disciplined for refusing to answer, or for not disclosing complete information in response to, questions asked. Once the questionnaire is complete, access to the information is limited only to specified staff within the RCJ.

	The RCJ considers the least upsetting placement for the alleged victim. Staff interviews confirmed that inmates at high risk for sexual victimization are not placed into protective custody unless the inmate cannot be protected by any other means. A review of status for protective custody is completed at a minimum of every 30 days. They have not placed any alleged inmate victims of sexual abuse or sexual harassment in involuntary segregated housing.

115.51	Inmate reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	RCJ provides multiple internal avenues for inmates to report sexual abuse, sexual harassment and retaliation (i.e. telling any staff member, submitting an inmate request through the kiosk, or writing to the PREA Coordinator). Inmates are provided the address to write either the North Dakota Department of Corrections and Rehabilitation or the North Dakota Bureau of Investigation. In addition, they may call the numbers provided for external sexual abuse victim's organizations to include Family Crisis Center or the National Rape Crisis hotline. Inmate interviews confirmed that inmates are aware of their options. The RCJ has not entered into a Memorandum of Understanding (MOU) with a sexual abuse victim's organization.
	CORRECTIVE ACTION: The auditor required the RCJ enter into a MOU with an external entity that is willing to accept calls from inmates to report sexual abuse. The RCJ lists the North Dakota Department of Corrections and Rehabilitation or the North Dakota Bureau of Investigation as an external entity for inmates to report. During the corrective action period they entered into a MOU with the Bottineau Family Crisis Center and provided the signed copy if this MOU to the auditor. The auditor verified with the Family Crisis Center that they are willing to accept these calls and report back to the facility.

	Inmates may file a grievance. All allegations of abuse/harassment when received by staff, would immediately result in an administrative or criminal investigation. Inmates are not required to use an informal grievance process or to otherwise attempt to resolve with staff an alleged incident of sexual abuse. An inmate may file an emergency grievance alleging an inmate is subject to a substantial risk of imminent sexual abuse. Staff will immediately forward such a grievance to the jail administrator for which immediate corrective action will be taken.

The inmate handbook does list both the address and the phone number for the Family Crisis Center in Bottineau even though the MOU had not been signed.
	CORRECTIVE ACTION: The auditor required the RCJ enter into a MOU to provide support services. The RCJ entered into an agreement with the Bottineau Family Crisis Center to provide these support services and provided the auditor with a signed copy of the MOU. The auditor spoke with the Family Crisis Center who stated they have agreed to provide the services.

	The RCJ had not provided information for third party reporting at the time of the on-site portion of the audit. Third parties include family members and other visitors, attorneys, religious volunteers or any other person providing information on behalf of an inmate. 	CORRECTIVE ACTION: The auditor required the RCJ provide information on how an individual can make a third party report on behalf of an inmate. The RCJ created a tri-fold pamphlet and posted this in visitation and in the waiting area. The pamphlet is given to inmates at booking and it is posted on their website. The brochure identifies information on how to report sexual abuse on behalf of an inmate.

Staff interviewed understood and spoke specifically about this procedure. Inmate interviews supported the fact that inmates are also aware of the reporting and confidentiality requirements of sexual abuse and sexual harassment.

	RCJ has a disciplinary process that allows for staff discipline if staff are involved in any type of sexual misconduct or for violating any agency sexual abuse or sexual harassment policies. Discipline can include dismissal or termination from employment.

115.67	Agency protection against retaliation

	The RCJ policy 8.07 Reporting Sexual Assault and Sexual Harassment covers all elements of this standard. The investigator is designated to monitor for retaliation up to a 90-day period or for as long as needed.

115.68	Post-allegation protective custody

	Auditor Discussion
	RCJ demonstrated compliance with all elements of this standard. After interviewing the Jail Administrator, staff assigned to supervise segregated housing, and inmates, there were no instances of using segregation to protect an inmate who had alleged to have been sexually abused. Staff stated segregated housing would only be used at the request of the inmate. There are multiple housing options available to provide adequate separation for the protection of an inmate. The standard practice would be to place the suspected abuser in segregated housing.

	The investigator has received specialized training to conduct sexual abuse investigations. All written reports will be retained for at least seven (7) years from inmate(s) discharge. Investigations will not be terminated due to the departure of an alleged abuser or victim. The facility will cooperate with outside investigators and will remain informed of the investigation progress.

	RCJ policy stipulates no standard higher than a preponderance of evidence will be used in making a determination of alleged sexual abuse/harassment. Through interviews with the investigator they use no standard higher than the preponderance of evidence in making final determinations of sexual abuse/harassment.

	RCJ policy requires inmates to be informed as to whether the allegation was substantiated, unsubstantiated or unfounded; whether the allegation involved staff, contractors, volunteers or another inmate. If a sexual misconduct allegation is confirmed, the inmate will be informed of the abuser's employment/volunteer/contractor status; and as appropriate of an indictment/conviction.
