	The RCJ written policy 8.01 mandates zero tolerance toward all forms of sexual abuse and sexual harassment. During the interview, the Jail Administrator/PREA Coordinator stated that although new to the position and still figuring out his duties, he has enough time to manage all PREA-related responsibilities. The auditor cautioned that the facility needs to work on institutionalizing the actions necessary to maintain compliance with all standards so that if administrators are changed, compliance with PREA standards continue.

115.12	Contracting with other entities for the confinement of inmates

	The facility does not contract for the confinement of its inmates with other private agencies/entities. They have an emergency plan to utilize the Heart of America Correctional and Treatment Center in the event of an emergency or natural disaster, but not as a facility to house inmates through a contractual relationship.

115.13 Supervision and monitoring

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed policy, the 2018 staffing plan, the organizational structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The RCJ has developed a staffing plan that was viewed by the auditor in 2018. However, the auditor was not provided any documented evidence that an annual review of the staffing plan was done to ensure that they assessed, determined, and documented whether adjustments were needed to: (1) The staffing plan established; (2) The facility's deployment of video monitoring systems and other monitoring technologies; and (3) The resources the facility has available to commit to ensure adherence to the staffing plan. The administrator checks for compliance through fulfilling the daily schedule.

They use video monitoring, electronic door monitoring and an intercom system to protect inmates against sexual abuse. Higher-level supervisors conduct unannounced visits, and the auditor viewed these rounds on their electronic log, the P1 LERMS System and took a sample screenshot of the rounds viewed.

CORRECTIVE ACTION: The auditor required an updated staffing plan. This document should be reviewed at a minimum of once each year.

The Jail Administrator provided an updated staffing plan which can be found in Policy 1.01 and is required to be reviewed annually. As the Jail Administrator and the auditor collaboratively worked on the updated staffing plan several key components were added to the staffing plan to include the following sections:

- More specific information regarding the number and types of staff, shift compositions and times and other mandatory requirements related to staffing.
- More specific information regarding the annual review of the facility, its procedural operations and investigative files as it relates to blind spots, or areas where staff or inmates may be isolated.
- A section that more thoroughly describes the inmate population.
- A requirement to review sexual abuse incidents that are in the annual report and aggregate data that is posted on the website with the specific intent to determine if the number of incidents require any adjustments to the staffing plan.

115.14	Youthful inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Rolette County Jail does not house youthful offenders.

115.15 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

The RCJ does not conduct cross-gender strip searches or cross-gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners. The RCJ trains line staff in the proper methods to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The auditor verified this in interviews with staff and a review of training records. In the event a cross gender search is needed, RCJ will document all cross-gender strip searches and cross-gender visual body cavity searches. There has been no cross-gender searches for this audit review period. All interviews with both inmates and staff confirmed the practice of male staff searching male inmates and female staff searching female inmates. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates.

The RCJ has policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures require staff of the opposite gender to announce their presence when entering an inmate housing unit. The auditor directly witnessed announcements throughout the audit. However, this practice was not confirmed through inmate interviews. This leads the auditor to believe that this practice is not consistent with all staff.

All camera views were adequately blocked to ensure that inmates have privacy to toilet, shower and change their clothing. RCJ will not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. If the inmate's genital status is unknown, it is determined during conversations with the inmate, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner.

CORRECTIVE ACTION: The Rolette County Jail must emphasize again that all staff consistently make an announcement as they enter an inmate housing area when the inmates are of the opposite gender. This practice must be consistent throughout the corrective action period.

The facility struggled with understanding the cross-gender announcement. The auditor and the Jail Administrator worked on the policy and procedures regarding this and that a failure to outline and implement consistently would result in non-compliance with this standard. By the end of the corrective action period, they gained understanding and the Jail Administrator updated the policy and re-trained staff to ensure consistent cross-gender announcements are made according to guidance as given in the FAQs and adding language that more specified what is acceptable and what is not acceptable with regard to the cross-gender announcement when entering housing.

115.16	Inmates with disabilities and inmates who are limited English proficient
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ provides interpretive services for inmates with disabilities or who are limited English proficient through a commercial service, the LanguageLine. The county emergency manager has set up the account and provided laminated materials to all jail staff. The inmates can point to their native language on a poster so that staff know which language is required. One of these notices is posted at the booking desk to assist the officer in contacting the LanguageLine interpretive services during the booking process. The RCJ does not rely on inmate interpreters or inmate readers and staff are aware of this policy as was verified during interviews with the staff

115.17 Hiring and promotion decisions Auditor Overall Determination: Meets Standard **Auditor Discussion** The RCJ conducts criminal background checks on applicants before an offer of employment is made. The auditor reviewed a random sampling of employee files to verify background checks. The RCJ uses a form to ask the three required questions outlined in this standard of prospective employees and promotions. These questions are: 1) have you ever engaged in sexual abuse in any criminal justice facility; 2) have you ever been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or 3) have you ever been civilly or administratively adjudicated to have engaged in the activity described above. The form also requires the prospective employee acknowledge that they understand they have a continuing duty to report any such misconduct. Although these questions are asked during the hiring process, these questions are not asked again during the annual employee review/evaluation process. CORRECTIVE ACTION: The auditor required the RCJ have all current staff complete an updated sexual misconduct form and to continue this process annually during the employee review process. The Jail Administrator provided updated Policy 1.04 on hiring procedures that more clearly defines what is required during the hiring process and in subsequent years. The auditor verified compliance with the sexual misconduct questions by requiring the Jail Administrator to provide the completed annual sexual misconduct forms from a random sample of employees' names.

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ moved into this new facility in January 2018. This facility has the latest in technology to include video monitoring systems, door access systems, and an intercom system. The facility has clear sight lines from the Master Control into the housing units for direct observation. In interviewing both the Sheriff and the Jail Administrator they consider how such technology may enhance their ability to protect inmates from sexual abuse.

115.21	Evidence protocol and forensic medical examinations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ has a trained facility investigator to conduct administrative investigations. The investigator has completed the PREA investigator training provided by North Dakota Department of Corrections and Rehabilitation. All criminal allegations are turned over to the North Dakota Bureau of Investigation to conduct the investigation. Victims of sexual abuse have access to forensic medical exams by a SANE nurse through Indian Health Services (IHS) on the Turtle Mountain Reservation. If the victim is not eligible for medical services at IHS, the forensic medical exam can be completed by the next closest SANE nurses at Trinity Health in Minot. The facility has a Memorandum of Understanding (MOU) with the Family Crisis Center in Bottineau for advocacy services. This advocacy service will provide support to victims of sexual assault.

115.22	Policies to ensure referrals of allegations for investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Investigative steps are properly outlined in the PREA policy number 8.08 Investigations. Interviews with the investigator, Sheriff and the Jail Administrator/PREA Coordinator confirmed that the RCJ ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment. The RCJ ensures that allegations of employee wrongdoing are referred for investigation to the North Dakota Bureau of Criminal Investigation. The RCJ policy 8.02 Investigations: Criminal and Administrative, Referrals, Coordinated Response is posted on their website at http://www.rolettecounty.com

115.31	Employee training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	This standard requires PREA training every year. The training can be viewed as three types of training. Newly hired employees will have PREA training that includes the ten (10) required components as outlined in the standard; existing employees will participate in refresher training every two years on the jail's current sexual abuse and sexual harassment policies and procedures; and in the years they do not receive refresher training, they will be provided refresher information on current sexual abuse and sexual harassment policies. Although there is quite a bit of documented training on various PREA subjects, the training documentation was sporadic with no documentation of some form of PREA training occurring every year for every employee.
	CORRECTIVE ACTION: The auditor required RCJ provide documented evidence of training for staff that acknowledges understanding of the ten required components outlined in the standard.
	The auditor verified compliance with the employee training requirements by requiring the Jail Administrator provide employee-signed training documentation that was conducted for new hires as well as refresher training conducted for existing employees from a random sample of employees' names.

115.32	Volunteer and contractor training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility only has one contractor, the medical provider. She stated she knew the basics – that there was a zero-tolerance policy and to report any reports of sexual assault or harassment to the Jail Administrator. She completed basic PREA training and specialized training for medical providers. There is one religious volunteer. The auditor was not provided training provided to the religious volunteer.
	CORRECTIVE ACTION: The religious volunteer has not participated in services at the facility since the onset of COVID. If he does resume these services, the facility will refresh his PREA training prior to providing religious services to inmates.

115.33 Inmate education

Auditor Overall Determination: Meets Standard

Auditor Discussion

Through inmate and staff interviews the auditor determined that the RCJ provides inmate education by going over it verbally with the inmate during booking and providing them a PREA information sheet. However, the auditor received no documentation of this training. Through inmate interviews the auditor determined that more comprehensive PREA information is given at a later date, but it appears this PREA class was only given up until mid-May. This is confirmed through the documentation that was provided. There is information on the kiosk regarding the zero-tolerance policy, how to report to either the Rolla Crisis Center or the Family Crisis Center in Bottineau. There number is also provided so that they may place a toll-free call to through the Rapid Crisis Hotline number but it does not state that this number routes them to the nearest local rape crisis center. The kiosk information does not emphasize that the rape crisis center can offer emotional support services to victims of sexual abuse. The kiosk information also states that they can call the State's Attorney and provides that number. All calls require an inmate PIN so there is no method for making a confidential or anonymous phone call. Although good information is provided through the kiosk, inmates often do no read this information or is it readily available near the phone if an inmate wanted to call any of the numbers provided.

CORRECTIVE ACTION: The auditor required documentation of the basic PREA training that is provided to inmates upon intake to the facility. This was provided to the auditor.

The auditor required the RCJ provide the more comprehensive information to inmates either through a video or in person. The training is to include their rights to be free from sexual abuse and sexual harassment; their rights to be free from retaliation for reporting and the agency policy and procedures for responding. The auditor required documented evidence that this training has been complete throughout the corrective action period. The Jail Administrator provided several signed training sheets from throughout the corrective action period.

The auditor required posters in each housing area that list the external reporting entity, that this is a free call, that the inmate can remain anonymous upon request and that this call is not recorded. Information for victim support services should also be provided on this poster. The Jail Administrator provided updated posters with this required information and an email from the facility's contracted telephone vendor that these numbers were added to the free call PIN number list.

The auditor required updated inmate educational material to include initial inmate training during intake, posters, the inmate handbook and the kiosk with new reporting procedures that includes the external reporting entity (see Standard 115.51 Inmate Reporting); that calling the external entity is a free call, that no inmate PIN is required, that the call is not recorded, and that the caller can remain anonymous upon request. The training material must clearly explain that the Rolla Crisis Center and the Family Crisis Center in Bottineau are for emotional support services to sexual abuse victims, and to what extent they are monitored. The Jail Administrator provided all materials as requested.

115.34	Specialized training: Investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ has trained a facility investigator to conduct administrative investigations. The PREA investigator completed specialized training provided by North Dakota Department of Corrections and Rehabilitation All criminal allegations are turned over to the North Dakota Bureau of Investigation.

115.35	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Registered Nurse is contracted for services. She has completed the National Institute of Corrections course "Medical Health Care for Sexual Assault Victims in a Confinement Setting". During the interview the RN was very knowledgeable about the appropriate response for transporting the inmate to the hospital for sexual assault forensic exams and protecting evidence to aid in the prosecution of a sexual assault. The RCJ does not provide in-house mental health services. Inmates are referred to a provider at the Lake Region Human Services Center or Indian Health Services Behavioral Health in Belcourt for mental health care.

115.41	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	All inmates are assessed during an intake screening for risk of being sexually abused by other inmates or sexually abusive toward other inmates. Intake screenings usually take place within the first few hours but most definitely within 72 hours of arrival at the RCJ. The RCJ uses an objective screening instrument. However, the auditor saw no evidence that the inmates are reassessed within 30 days of arrival. The Jail Administrator does reevaluate when there is an incident, upon request or when there is additional information. However, reassessments are not documented.
	CORRECTIVE ACTION: The auditor required that the RCJ devise a method for reevaluating an inmate's risk within 30 days of arrival and documenting that reevaluation.
	The Jail Administrator provided the rescreening tool he developed to track all rescreening information, updated and trained staff on the procedures for rescreening and provided random samples of inmates who had been rescreened using the document.

115.42	Use of screening information
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Rolette County Jail makes individualized determinations about how to ensure the safety of each inmate. In deciding whether to assign a transgender or intersex inmate to a housing unit for male or female inmates, and in making other housing and programming assignments, the RCJ considers on a case-by-case basis whether a placement would ensure the inmate's health and safety, and whether the placement would present management or security problems. A transgender or intersex inmate's own view with respect to his or her own safety would be given serious consideration. All inmates shower separately. RCJ does not place lesbian, gay, bisexual, transgender, or intersex inmates in dedicated units solely on the basis of such identification. An inmate's risk level is reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information that bears on the inmate's risk of sexual victimization or abusiveness. Inmates are not disciplined for refusing to answer, or for not disclosing complete information in response to, questions asked. Once the questionnaire is complete, access to the information is limited only to specified staff within the RCJ.

115.43	Protective Custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The RCJ considers the least upsetting placement for the alleged victim. Staff interviews confirmed that inmates at high risk for sexual victimization are not placed into protective custody unless the inmate cannot be protected by any other means. A review of status for protective custody is completed at a minimum of every 30 days. They have not placed any alleged inmate victims of sexual abuse or sexual harassment in involuntary segregated housing.

115.51 Inmate reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor interviewed administrators, staff, and inmates, reviewed policy and toured the facility. The Rolette County Jail provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. At the time of the on-site portion of the audit the Rolette County Jail was utilizing the Rolla Crisis Center and the Family Crisis Center in Bottineau as its external reporting entities. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The auditor discussed different options that they should pursue to find an alternate external reporting agency for inmates. Upon deciding an external reporting entity, the Rolette County Jail needs to ensure that the numbers to this entity does not require an inmate PIN to call and that these calls can remain confidential to protect the anonymity of the inmate if requested. The inmate handbook also states that the inmate can write to the Bureau of Investigation and the North Dakota Department of Corrections. The addresses to these entities are provided.

As required by standard 115.53, the Rolette County Jail must inform inmates, prior to giving them access to confidential support services, of the extent to which such communications will be monitored and the extent to which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws.

CORRECTIVE ACTION: The auditor required an alternate method for inmates to report sexual abuse and sexual harassment to an external entity. The facility must also provide documentation from their phone service provider that this number does not require an inmate PIN and is set up to not be recorded. All inmate training materials must be corrected with this updated process (see Standard 115.32 Inmate Education for further details).

The Jail Administrator provided a Memorandum of Understanding with neighboring Bottineau County Sheriff's office who will accept calls from inmates reporting sexual abuse while housed at the Rolette County Jail. All housing posters, inmate handbooks, and the kiosk were updated with this revised reporting method. In addition, the Jail Administrator provided the auditor an email from the facility's inmate phone service provided that this has been set up as free call for inmates and will not be recorded.

115.52 **Exhaustion of administrative remedies** Auditor Overall Determination: Meets Standard **Auditor Discussion** The auditor reviewed the PREA policy, Grievances Policy 4.02 and interviewed staff. Inmates may file a grievance. All allegations of abuse/harassment when received by staff, would immediately result in an administrative or criminal investigation. There is no time limit on when an inmate may submit a grievance regarding an allegation of sexual abuse. An inmate may file an emergency grievance alleging an inmate is subject to a substantial risk of imminent sexual abuse. Staff will immediately forward such a grievance to the jail administrator for which immediate corrective action will be taken. There are a few points between the PREA Policy and the Grievances Policy that are contradictory. The Grievances Policy states that an inmate can only pursue a grievance about an issue that affects them personally. The PREA Standard requires that third parties, including fellow inmates, are permitted to assist inmates in filing requests for administrative remedies relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of inmates. The Grievances Policy states the goal is to resolve all grievances on an informal level and if an informal resolution cannot be reached, the inmate can write a formal grievance. The PREA standard requires that the jail not require an inmate to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. CORRECTIVE ACTION: The auditor required clarifying language within the Grievances Policy 4.02 that an inmate may file a grievance of sexual abuse on behalf of another inmate and that an inmate may file a grievance of sexual abuse without attempting resolution through an informal grievance process. The Jail Administrator updated Policy 4.02 with language that allows an inmate to file a grievance of sexual abuse on behalf of another inmate and that an inmate may file a grievance of sexual abuse without attempting resolution through an informal

grievance process.

	The RCJ provides the number to contact the Family Crisis Center and the National Rape Crisis hotline to provide inmates with confidential emotional support services related to sexual abuse. The inmate handbook does list both the address and the phone number for the Family Crisis Center in Bottineau. The auditor verified with the Family Crisis Center in Bottineau that they will provide these services as listed in the MOU.

Discipline can include termination from employment.

	The auditor reviewed policy and interviewed the jail administrator and the staff assigned to monitor for retaliation. Policy 8.07 Reporting Sexual Assault and Sexual Harassment covers all elements of this standard. The investigator is designated to monitor for retaliation up to a 90-day period or for as long as needed. He has the authority as the night shift supervisor and the investigator to perform periodic status checks and discuss discipline with the Jail Administrator to monitor the conduct and treatment of inmates or staff who reported the sexual abuse and of inmates who were reported to have suffered sexual abuse to see if there are changes that may suggest possible retaliation by inmates or staff so that a remedy can be made to prevent further retaliation.

	The RCJ demonstrated compliance with all elements of this standard.
